Part A: Pupil premium strategy plan

Statement of intent

At Laughton CP School we have high aspirations for all our children and believe that no child should be left behind. We aim to develop a thirst for knowledge, a commitment to learning and to give every child in our school every chance in life.

Although our pupil premium funding is not a major proportion of our budget, it is a significant amount of money and we are determined to ensure that it is used to its best effect. With this in mind we research the best ways to use this funding and have generally focused on interventions which have been shown to have particular impact.

When making decisions about using the funding, we look at common barriers to learning such as support at home, language and communication skills, social and emotional aspects of learning including confidence, attendance and punctuality issues. Complex family situations may sometimes prevent children from flourishing and can present as another significant barrier to learning.

Our main objective in deciding how to use the pupil premium funding is to ensure that the gap between groups of pupils is narrowed. We aim to ensure that targeted interventions help remove barriers to learning and progress.

Staff believe that all children can succeed. We celebrate individual strengths and have high expectations for all children. The school community works hard to develop resilience and perseverance in all our children.

Children's progress is analysed termly. Plans and strategies are reviewed following that analysis to ensure the best possible outcome for all children, including non-disadvantaged children. We use current research to support us in planning strategies that will be most effective in improving outcomes.

All staff are aware of pupil premium children and other vulnerable groups across the school. All Pupil Premium children benefit from the funding and the school responds flexibly to the needs of individual children.

All staff have high expectations and follow a robust system of feedback and assessment. We aim to maximise teaching time by improving attendance and punctuality. We identify barriers to learning and provide early intervention.

Challenges

Part B: Review of the previous academic year

Outcomes for disadvantaged pupils

Attendance for PP children in **2024-2025** was **87.7%** compared to **94.1%** for all other pupils. The attendance for all children at Laughton has been maintained to that of the previous academic year.

Pastoral and emotional support continues to be a high priority for all pupils, but especially for those who are disadvantaged/vulnerable. Strategies are in place to support vulnerable children in coming into school. This is having a positive impact and we would expect attendance figures to improve further to reflect this over the next academic year.

Regular visits from TASS have been beneficial to support families who experience difficulty coming into school, and has led to improved understanding of need.

Thrive strategies were implemented to support children in learning to help build resilience, confidence and self-esteem whilst providing knowledge for individual progression. There has been positive feedback from our families and the sessions have enabled some children to become independent learners and to recognise and manage their internal emotional regulation system.

Support resources, and small group and one-to-one interventions continue to have an impact on the progress of PP pupils. Termly reviews of progress is evidenced in provision maps highlighting the results of providing additional support.

End of Year Teacher Assessment:

Reading

25% of PP are working at EXS+, **16.6%** of PP children are working at EXS, **41.6%** at WT, and **16.6%** WB

30.1% of non PP are working at EXS+, **39.6%** of non PP children are working at EXS, **24.5%** at WT, and **5.6%** WB

Writing

25% of PP children are working at EXS, **33.3%** WT, and **41.6%** WB

1.8% of PP children are working at EXS+, **52.8%** of non PP children are working at EXS, **35.8%** WT, and **9.4%** WB

Maths

8.3% of PP are working at EXS+, **25%** of PP children are working at EXS, **41.6%** WT, and **25%** WB

13.2% of non PP children are working EXS+, **56.6%** of non PP children are working at EXS, **28.3%** WT, and **1.8%** WB

Although there is a gap between PP and non PP children, evidence demonstrates that there has been progress made from the individual starting points of PP Children.

Pupil progress shows there is evidence in positive attitudes to learning and pupil voices show that children are engaged in learning and recognising their own achievements.

All children have access to IT at school to support learning. There is an increased use of Clicker 8 as a tool for writing. IT interventions are well established and are impacting on Pupil Progress.

There is a high attendance of educational visits for PP children. Enrichment activities have had a positive impact on learning within the classroom and pupils have better engagement in lessons with trips relating to their topics.

A positive relationship has been developed with parents who actively seek support from our pupil premium champion. Parents are aware what support is available through meetings and regular communication.

The majority of PP children successfully met the end of KS2 swimming objectives. Those who did not meet the objectives, still progressed from their starting points. Weekly feedback was given between swimming coaches and staff, along with assessment papers to evidence pupils' progress. Children were proud of their achievements.

Breakfast items, fresh fruit, and milk offered on a daily basis to identified children enabled equality and access.

The purchase of uniforms has led to pupils feeling smart and proud to be identified as a member of the school community.
